1. NAME :

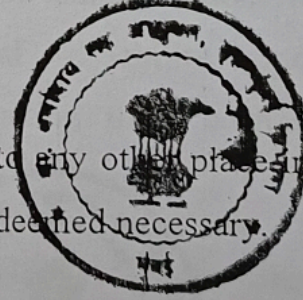
The name of the society shall be “SELF ADVOCATES’ FORUM”

3. AIMS AND OBJECTIVES:

The aims and objective for which the society, **SELF ADVOCATES’ FORUM** is established are as follows:

To function as the Apex Council at the National level and work by providing support, advice and help to Persons with Autism, Cerebral Palsy, Intellectual and Multiple Disabilities,



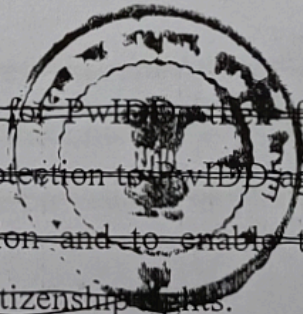

To work towards implementation of all legislations relating to Persons with Autism, Cerebral Palsy, Intellectual and Multiple Disabilities (PwIDD) and to create an environment, where *PwIDD can develop and flourish to the best of their abilities*, so as to promote general welfare of PwIDD and their families towards a gainful living and social integration with dignity.
- iii. To endeavor to bring all Persons with IDD under the common umbrella of Self Advocates Form of India by facilitating formation of chapters of Self Advocates Forum of India across the country at the district and local levels and to work as a pressure group with appropriate authorities to achieve the above aims and objectives.
- iv. Promotion of Self Help Groups among Persons with Autism, Cerebral Palsy, Intellectual Disability and Multiple Disabilities (PwIDD) for making them economically self sufficient.

- vi. To promote the interest of PwIDD and their families by bringing about co-ordination and co-operation among the PwIDDs, local Parents' Associations, Organizations, other

Institutions, Professionals rendering services for the cause and well wishers at the taluka, district and State levels.

- vii. To lobby with the concerned departments of the State as well as Central Governments and Office of the Chief Commissioner and State Commissioners for PwDs so as to pressurize the Central and State Governments for effectively implementing the provisions of all legislations meant for the rights and welfare of PwIDD.
- viii. To organize public awareness programmes at national, state, district and local levels, involving Parents' Organizations, professionals and community at large through print and electronic media and law enforcing authorities.
- ix. To secure appropriate representation in the National Co-ordination and State Co-ordination Committees and under the provisions of the ~~Rights of Persons with Disabilities Act, 2016~~, and any other authority/committees created by the Central and State Governments.
- x. ~~To secure inclusion of representatives of Self Advocates Forum as members of the Local Level Committees for proper implementation of the provisions of the National Trust Act, 1999.~~
- xi. To secure nominations of representatives of Self Advocates Forum as executive members of Parents Organizations, State Federations of Parents Organizations and National Confederation of Parents Organizations.

- xii. To encourage Self Advocacy amongst PwIDD and to include Self Advocates in appropriate forums, seminars and meetings.
- xiii. To create synergy with State Government so that all Government Projects, Schemes and Intervention Programs are made more realistic and disabled friendly.
- xiv. To ensure proper implementation of inclusive education programs including Sarva Shiksha Abhiyan and to ensure formation of more co-curricular and integrated programs.
- xv. To take all necessary action in regards to proper implementation of all State and National Legislations, United Nations Conventions, Recommendations, Rules and Regulations, for furtherance of the interests ~~and rights of~~ PwIDD including Legal, Civil, ~~Human Rights~~ as in enshrined in the constitution of India and ~~United Nations Convention on Rights of Persons with Disabilities~~ (UNCRPD).
- xvi. To secure Comprehensive Health Care in Government Hospitals/Primary Health Care Centers for PwIDD under one roof, where all relevant facilities are available.
- xvii. To ensure free health care and treatment in Government Hospitals and Primary Health Centers including pre-natal diagnosis of disability and appropriate prevention and intervention and to secure reservation of beds exclusively for PwIDD.
- xviii. To include drugs and medicines required for the regular use of PwIDD in the "Essential Life Saving Drugs" list of the State

- xix. To encourage Parents Associations and Non-Parents Associations get agreed to establish the necessities of PwIDD viz. Early Intervention Centre, Vocational Training Facility Centre and Short Term and Long Term Residential facility Centre, Day Care Centre.
- xx. To design, develop and undertake documentation & dissemination.
- xxi. To do all things, as may be necessary and conducive for pursuance attainment of the aims and objectives of the society, SELF ADVOCATES' FORUM.

3. In order to achieve all or any of the above objectives of the society, SELF ADVOCATES' FORUM shall have the power *inter alia*:

- i. To frame rules and the bye-laws under this Memorandum of Association.
- ii. The Management and Supervision of the affairs of SELF ADVOCATES' FORUM shall be carried on in accordance with the Rules and Regulations as may be framed or modified from time to time by the Executive Council.
- iii. To raise funds for SELF ADVOCATES' FORUM by receiving entrance fee, subscription (membership), donations, sponsorships and by any other approved means.

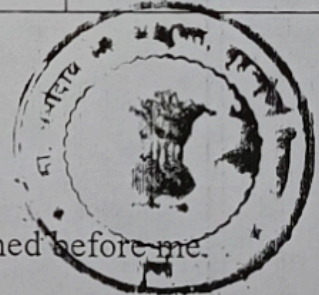
